Report on the Administration of the *Access to Information Act* for the period 2021-04-01 to 2022-03-31

1. Introduction

The St. John's Port Authority (SJPA) was established pursuant to the *Canada Marine Act (CMA)*, which received Royal Assent on May 1, 1999. The *CMA* repealed the Canada Ports Corporation Act of 1983.

The SJPA's mission is to provide reliable, economic and efficient port services for the purposes of supporting Canadian trade, fostering regional economic development, and serving Newfoundland and Labrador's distribution requirements.

The purpose of the *Access to Information Act (ATIA)* is to extend the present laws of Canada to provide a right of access to information in records under the control of a government institution in accordance with the principles that government information should be available to the public, that necessary exceptions to the right of access should be limited and specific, and that decisions on the disclosure of government information should be reviewed independently by government.

This report is prepared in accordance with section 94 of the *Access to Information Act* and the annual reports are prepared and tabled in Parliament in accordance with section 72 of the *Act* and section 20 of the *Service Fees Act*.

This report covers the fiscal year 2021-04-01 to 2022-03-31.

2. Structure of the Access to Information Office

The responsibility for processing requests received under the *Access to Information Act* rests with the President and Chief Executive Officer, who ensures compliance with the legislation.

Administration of the *Access to Information Act*: The staff complement at the SJPA is 13. The President and CEO is the Access to Information Coordinator. The Vice President, Finance & Administration is the Authorizing Representative. The Executive Assistant is an Officer. Procedures for handling Access to Information requests are well known throughout our institution.

3. Delegation Order

The Access to Information Coordinator is Mr. Sean Hanrahan, President and Chief Executive Officer, who is the head of our institution. There has been no further delegation by the President and CEO setting out the powers, duties and functions for the administration of the *Access to Information Act*. The President and CEO ensures that any requests are processed in accordance with the provisions of the Act.

4. **Performance 2021-2022**

The SJPA received two requests during the 2021-2022 fiscal year.

100% of requests were responded to within legislated timelines, the following exemptions were invoked; s.2.20(1) of the *Access to Information Act*; s.375(6) of the *Marine Transportation Security Regulations* and s.61(1) and (2) of the *Canada Marine Act*. Both requests received during the reporting period are currently under review by the Office of the Information Commissioner.

There were no consultations for other institutions.

There was little to no impact on the SJPA's ability to fulfill its *Access to Information Act* responsibilities as a result of COVID-19-related measures.

There are no outstanding requests or active complaints from previous reporting periods.

SJPA's "Statistical Report on the *Access to Information Act*", previously validated by Treasury Board Secretariat, which provides statistical data on requests received by the SJPA during the current reporting period, is attached.

In the past eleven years, a total of nine requests have been received, averaging less than 1 request per year. All completed requests were finalized in under 30 days, not costing more than \$150.00 each. Previous exemptions invoked; s.20(1)(b),(c) on the 2010 & 2011 requests; s.20(1)(b) on the 2013; s.21(1)(a),(b) on the 2011 request; s.17 on the 2021 request and s.18(b) on the 2010 request. Given the limited number of Access to Information requests received at the SJPA, no identifiable trends have been established.

5. **Training and Awareness**

During the 2021-2022 reporting period SJPA's ATIP staff participated in; ATIP Community Meetings on September 28, 2021 and January 28, 2022; attended the Access to Information Innovation Showcase on March 3, 2022; and took the ATIP Online Management Tool training session on April 13, 2022.

6. **Policies, Guidelines, Procedures, and Initiatives**

The SJPA posts all requests, and monthly summaries of same, through the Open Government portal. All historical reports, originally published on the SJPA website, from December 2011 to July 2018, are available through the portal. The SJPA did not implement any new or revised institution-specific policies, guidelines and procedures related to access to information during the reporting period.

7. **Summary of Key Issues and Actions Taken on Complaints**

There were no access to information complaints received by the SIPA during the reporting period, therefore there were no key issues raised or actions taken.

8. **Monitoring Compliance**

As the SIPA receives very few requests, beyond ensuring that requests are completed in a timely manner in accordance with the *Access to Information Act*, person hours are not logged by a clock-in/out system. Should a request result in a significant workload staff would be directed to track time spent on the task by logging start and end times. Executive management advised, including the President & CEO.)

9. **Reporting on Access to Information fees for the purposes of the Service Fees Act**

The *Service Fees Act* requires a responsible authority to report annually to Parliament on the fees collected by the institution.

With respect to fees collected under the *Access to Information Act*, the information below is reported in accordance with the requirements of section 20 of the *Service Fees Act*.

- The enabling authority is the *Access to Information Act*.
- The \$5.00 application fee is the only fee charged for an ATI request.
- The total fee revenue for the 2021 to 2022 fiscal year was \$10.00 (ten dollars).
- No fees were waived for the 2021 to 2022 fiscal period.
- Cost of operating the program for the fiscal year was \$5,800.00.
